**THE GOVERNMENT FEES AMENDMENT REGULATIONS 1998**

In exercise of the powers conferred upon him by section 2(1) of the Government Fees Act 1965, and every other power vested in him, the Minister of Finance makes the following Regulations:—

**Citation**

1 These Regulations may be cited as the Government Fees Amendment Regulations 1998.

**Revocation and replacement of Schedule to S.R.& O. 24/1976**

2 The Schedule to the Government Fees Regulations 1976 is revoked and the Schedule set out in the Schedule to these Regulations is substituted.

**Commencement and transitional**

3 (1) Subject to paragraph (2), these Regulations commence on 1 April 1998 ("commencement day").

(2) Nothing in these Regulations affects the validity or effect of a fee that was paid—

(a) before commencement day; and

(b) in respect of a period that was still running on that day.

"re-inspection of works" means a re-inspection made necessary because, at a previous, scheduled visit to the works, either—

- (a) conditions at the works prevented proper access to the works; or
- (b) the works did not meet the requirements of the Bermuda Building Code; or
- (c) the works for some other reason were not available or ready for inspection; or
- (d) a copy of the approved drawings was not available on-site.
