Her Excellency the Governor, on the advice of the Minister responsible for health, and in exercise of the power conferred by section 107B of the Public Health Act 1949, makes the following Regulations:

Citation

1 These Regulations, which amend the Public Health (COVID-19 Emergency Powers) (Phased Re-opening) Regulations 2021 (“the principal Regulations”), may be cited as the Public Health (COVID-19 Emergency Powers) (Phased Re-opening) Amendment (No. 8) Regulations 2021.

Amends regulation 2

2 In regulation 2 of the principal Regulations, delete the definition of “night-time curfew”.

Revokes regulation 3A

3 Regulation 3A of the principal Regulations is revoked.

Amends regulation 5

4 In regulation 5 of the principal Regulations, delete “20” wherever it appears and substitute “30”.

Amends regulation 6A

5 In regulation 6A of the principal Regulations, revoke paragraph (1)(b).

Amends regulation 8A

6 In regulation 8A of the principal Regulations, revoke paragraph (b).

Revokes regulation 15A

7 Regulation 15A of the principal Regulations is revoked.

Amends regulation 17A

8 In regulation 17A of the principal Regulations, in paragraph (1), delete “20” and substitute “30”.

Amends regulation 17AA

9 In regulation 17AA of the principal Regulations—

(a) in paragraph (1)(a), delete “20” and substitute “30”;

(b) paragraphs (2) and (3) are revoked.

Amends regulation 18

10 In regulation 18 of the principal Regulations, in paragraph (1), delete the words “and where the person” to the end.

Revokes Schedule 1A

11 Schedule 1A to the principal Regulations is revoked.

Commencement

12 These Regulations shall come into effect at 6am on 1 November 2021.
