#### **SCHEDULE**

The Minister of Finance, in exercise of the powers conferred by section 13 of the Bermuda Monetary Authority Act 1969, and on the recommendation of the Bermuda Monetary Authority makes the following Regulations:

#### **Citation**

1 These Regulations may be cited as the Bermuda Monetary Authority (Commemorative Coin Series) (Bermuda Sea Creatures) Regulations 2025.

#### **Interpretation**

2 In these Regulations—

“Authority” means the Bermuda Monetary Authority; and

“commemorative coins” means the Bermuda Sea Creatures Commemorative Coins to be issued under these Regulations.

### **Issue of commemorative coins**

3 The Authority may, in accordance with the specifications set out in these Regulations, issue the commemorative coins.

### **Denomination of commemorative coins**

4 The denominations of the commemorative coins shall be as follows—

- (a) Coin 1 – one ounce silver (colour) - \$2; and
- (b) Coin 2 – one-twentieth ounce gold - \$5.

### **Form and design**

5 The form and design of the commemorative coins shall be in accordance with the sample coins deposited with the Authority and in particular—

- (a) the obverse design of every commemorative coin shall be the portrait of His Majesty King Charles III in profile, together with the inscriptions “BERMUDA”, “CHARLES III” and every commemorative coin shall respectively bear the years—
  - (i) “2026” (on the Spiny Lobster commemorative coin);
  - (ii) “2027” (on the Stoplight Parrotfish commemorative coin);
  - (iii) “2028” (on the Humpback Whale commemorative coin);
  - (iv) “2029” (on the Spotted Eagle Ray commemorative coin);
  - (v) “2030” (on the Portuguese Man O’ War commemorative coin); and
  - (vi) “2031” (on the Flying Gurnard commemorative coin);
- (b) the reverse design of every commemorative coin of the series shall respectively depict—
  - (i) a Spiny Lobster (*Panulirus argus*), on the Spiny Lobster commemorative coin;
  - (ii) a Stoplight Parrotfish (*Sparisoma viride*), on the Stoplight Parrotfish commemorative coin;
  - (iii) Humpback Whale (*Megaptera novaeangliae*), on the Humpback Whale commemorative coin;
  - (iv) a Spotted Eagle Ray (*Aetobatus narinari*), on the Spotted Eagle Ray commemorative coin;
  - (v) a Portuguese Man O’ War (*Physalia physalis*), on the Portuguese Man O’ War commemorative coin; and
  - (vi) a Flying Gurnard (*Dactylopterus volitans*), on the Flying Gurnard commemorative coin;
- (c) the shape of every commemorative coin shall be three lobed.

**Standard weight and composition**

6 The standard weight and composition of the commemorative coins, and the amount of tolerance and variation allowed therein shall be as set forth in the Schedule.
