GOVERNMENT FEES AMENDMENT REGULATIONS 1996

In exercise of the powers conferred upon him by section 2(1) of the Government Fees Act 1965, and every other power vested in him, the Minister of Finance makes the following Regulations:—

Citation

1 These Regulations may be cited as the Government Fees Amendment Regulations 1996.

Revocation and replacement of Schedule to S.R.& O. 24/1976

2 The Schedule to the Government Fees Regulations 1976 is revoked and the Schedule set forth in the Schedule to these Regulations is substituted.

Commencement and transitional

3 (1) Subject to paragraph (2), these Regulations commence on 1 April 1996 ("commencement day").

(2) Nothing in these Regulations affects the validity or effect of a fee that was paid—

(a) before commencement day; and

(b) in respect of a period that was still running on that day.

"accessory structures" include, but are not limited to, tennis courts, parking areas, driveways, docks, walls, satellite dish receivers, piers and platforms, balconies, patios, verandahs and like structures which do not result in the creation of additional enclosed floor space not otherwise defined as minor works, that are incidental to the principal building and located on the same lot;

"minor works" means any building operation defined as permitted development under the Development and Planning (General Development) Order 1975;

"re-inspection of works" means a re-inspection made necessary because, at a previous, scheduled visit to the works, either—

- (a) conditions at the works prevented proper access to the works; or
- (b) the works did not meet the requirements of the Bermuda Building Code; or
- (c) the works for some other reason were not available or ready for inspection:

Provided that, in the case of an existing building where the application relates to building works designed specifically to provide access for, or otherwise meet the needs of, the physically handicapped, no fee shall be charged; and

Provided that, in the case of alterations or extensions to a building listed as a building of special architectural or historical interest in accordance with section 30 of the Development and Planning Act 1974, no fee shall be charged.
