BERMUDA IMMIGRATION AND PROTECTION (LICENCE APPLICATION) REGULATIONS 2007

BR 60 / 2007

The Minister responsible for immigration, in exercise of the powers conferred by section 102D(1)(a) of the Bermuda Immigration and Protection Act 1956, makes the following Regulations:

Citation

1 These Regulations may be cited as the Bermuda Immigration and Protection (Licence Application) Regulations 2007.

Application

2 (1) An application under section 84 of the Bermuda Immigration and Protection Act 1956 for the issue of a licence to hold or acquire land in Bermuda shall—

- (a) in the case of a restricted person, be in the form and contain the information and documents set out in the First Schedule or the Second Schedule, as applicable; and
 - (b) in the case of a trustee, be in the form and contain the information and documents set out in the Third Schedule or the Fourth Schedule, as applicable.
- (2) In the case of land that is purchased, the application shall include
- (a) copies of any advertisements for the sale of the land; and
 - (b) a written statement provided by the seller confirming that persons who possess Bermudian status have been provided with a fair opportunity to acquire the land.
