The Minister of Finance, in exercise of the power conferred by the Customs Procedure Code 4140 of the Fifth Schedule to the Customs Tariff Act 1970, makes the following Notice:

Citation

1 This Notice may be cited as the Customs Tariff (Approved Organizations - CPC 4140) Notice 2018.
